Attendees to last week's lunch meeting received a presentation on the history of Boy Scout Troop 60 by Scout House Foundation President John Hamon as well as updates on current activities by Scoutmaster Steve



von Dohlen (*left*) and Board member David Athey. The presentation highlighted the efforts by numerous club members in the successful funding and construction of the new Scout House. The new 3,000 sq ft facility is 300% larger than the metal buildings that served local scouting organizations for 75 years. It was noted that scouting has been in Paso Robles since the 1920s, not very long after the Boy Scouts were founded in 1910. In 1948, Rotarian Don Orcutt (father of Jeff) led efforts to

donate a vacant lot at Oak & 23rd Street to the Scouts. About 70 years ago two WWII era surplus metal buildings were moved to the site and Rotary began its chartered sponsorship along with local Elks and Kiwanis clubs. The two original troops, Troop 62 & 63, were merged into a single Troop 60 in the late 1960s with Rotary as the only chartered sponsor. The south building was dedicated to Curtis Cropper, a Vietnam era naval aviator killed returning from action in 1970.

In recent years, Troop 60 along with Cub and Venture Scout organizations started planning on a larger, modern facility that could accommodate larger groups and meet ADA requirements. At the same time, our Board undertook a major project to create a new Scout House Foundation separate and distinct from our Rotary Club. The new Board consists of Rotarians John Hamon (CEO), Phil Cagliero (CFO) and Bernard Olsen (Secretary) as well as Kevin Hanson, Kermit Kamm, and David Athey from the Scouts. Architect Nick Gillman and general contractor Gary Tucker worked to design and build the new Scout House utilizing many subcontractors who provided services at cost saving of ~\$120 K. The dedication on March 4 was the culmination of efforts by many Rotarians (see list on page 2) and provides the community with a dedicated facility that is rare and unique in the world of scouting.
