Stacie Jacob was born to promote and she is using her considerable talents and experience to improve tourism growth in Paso Robles. Stacie is the interim director of Travel Paso, a non-profit organization that works with all facets of the local tourism industry to develop strategies to promote more tourism in the region. Her work is vital to the economic interests of San Luis Obispo County as tourism generated an estimated \$1.59 billion in economic activity in 2016. That translates into \$50 per second spent by guests every day in SLO County and generated \$61.7 million in local tax revenue. Last year, tourism created 440 new jobs in the county or one out of every 8 of all jobs created.



Stacie harbors a lifelong passion for agriculture and a keen understanding of regional branding. She grew up in the Midwest and graduated from the University of Nebraska. She started her career working for the global public relations firm Fleishman-Hillard in Kansas City and then moved to Seattle as the first ever PR director for the Washington Wine Commission. After a successful 4 year stint in Seattle, she moved to the Central Coast as Executive Director of the Paso Robles

Wine Alliance. After 7 years of raising the region's global prominence in the wine trade, she became CEO of Visit SLO County where she continued to apply her marketing skills leading the county's destination marketing organization. She also founded Solterra Strategies and is providing leadership and expertise in the new Travel Paso organization where she manages a \$1.28 million marketing budget.

As the interim director of Travel Paso, Stacie is developing the tools to measure key metrics of tourism trade. She is launching new core branding initiatives and participating in a broad variety of trade shows. Stacie is also developing and enhancing numerous strategic partnerships leveraging her new Board of Directors who represent various facets of the tourism industry. Stacie closed her presentation by telling her audience to "consider the pasobilities" to grow our regional tourism.
