David Cooke, Executive Director Paso Robles Housing Authority (PRHA)

Paso Robles Housing Authority is demonstrating success in the creation and sustainability of affordable housing in Paso Robles. Their mission statement is to "provide quality, affordable housing, that promotes quality of life through a healthy community." David Cooke leads the administrative staff and reports to the Board Chairman Harry Ovitt. David was introduced by Bob Fonarow

who previously served on the Board.

David began his presentation by outlining the history of Oak Park. The original development of 148 units was built in 1942 to serve the enlisted men, women, & families of Camp Roberts during WWII. In the early 1950's, it was converted to HUD low income housing and remained as such for the next 58 years. In 2012, the Housing Authority committed to the demolition of the existing units



(over time) and the construction of up to 302 units of new affordable family style apartment home in four phases. The rents are targeted to qualified families making 30-60% of SLO County median income. To date, two phases of the project, Oak Park 1 & 2 are complete. They offer a total of 150 beautiful new affordable family style apartment homes. They are currently 100% leased with a waiting list of over 400 applicants demonstrating the need and attractiveness of this development. Phase 3 has secured financing and will begin construction soon.

Additionally, the Housing Authority sponsors on-site children programs, including its own YouthWorks Program and ACORNS after school programs. These programs provide mentoring, homework support, paid work and job skill development as well as scholarships. The Youth Works program alone serves over 400 youths. It success can be measured in part by the 99.9% on-time graduation rate of its participants. David expressed gratitude for our club's \$5,000 sponsorship of this nonprofit organization that addresses an urgent community need.
