Perhaps no issue is of greater interest to SLO County residents than water and Derrick Williams is currently the point man assisting local government officials in developing the legislatively mandated Groundwater Sustainability Plan (GSP) for the Paso Robles Basin. Derrick (*below left*) was introduced by Paso Robles Public Works Director Dick McKinley (*below right*) who will be responsible for providing the necessary city infrastructure and many of the management actions to support the plan.



The planning behind the development of the GSP is very complex in part because the Paso Robles Basin covers a large area that is under the jurisdiction of six groundwater sustainability agencies (GSAs) including SLO County, City of Paso Robles, San Miguel Community Services District, Heritage Ranch Community Services District, Shandon-San Juan Water District, and the Salinas Valley Basin GSA in Monterey County. As Dick McKinley quipped “Whiskey is for drinking and water is for fighting over” and balancing the diverse needs among various constituencies and agencies involved will be extremely challenging. To add to the challenge, planners must establish sustainability goals, develop processes & criteria to define “undesirable results”, establish minimum thresholds & sustainability indicators, define “measurable objectives” to obtain the sustainability goals in 20 years, and define various projects & management actions to support these goals. Among the management actions will be potential forms of demand management as well as supply enhancement projects. And planners only have 18 months to complete the initial GSP.

Accommodating the growing needs of diverse users requires a broad set of water sources including recycled waste water for agriculture. With 37,400 acres of “new” agriculture in our region, these new sources will be essential in meeting future needs.
