John Shoals Senior Public Affairs Representative, PG&E

John Shoals is a very busy guy. Not only does he represent PG&E on numerous high profile issues, but he also finds time to serve as Mayor of Grover Beach, a position he was elected to 3 times. One of his priority issues for PG&E is explaining the Joint Proposal for the orderly retirement of the Diablo Canyon Power Plant (DCPP) at the end of its current Nuclear Regulatory Commission (NRC) operating licenses, which expire in 2024 & 2025. The joint proposal developed by PG&E, labor & environmental groups has been scrutinized by the communities that will be economically impacted by its shutdown. The Joint Proposal is now under review by the CA Public Utilities Commission (CPUC).

John grew up in Riverdale and attended Cal Poly where he played basketball and received a BS degree in City & Regional Planning from the School of Architecture. He and his wife Staci have lived for 28 years in Grover Beach, raising 2 daughters and staying actively involved in city government and non-profits.

John began his presentation by providing an overview of PG&E, a gas and electric utility that serves over 16 million people and a region of 70,000 sq. mi.



John noted they are one of the "greenest" power companies in the U.S. with 29% of their power coming from renewable sources (not counting nuclear or large hydro). John stated that the decision to retire DCPP is due to falling demand as well as changing market and regulatory conditions. DCPP will be replaced by renewable sources and greater energy efficiencies. \$85 million has been proposed in support of a community transition plan to offset lost tax revenues. The employee plan will include incentives to stay during the remaining operating years of the plant, a retraining and development program to facilitate redeployment of some of plant personnel to the decommissioning project or other positions within the company, and severance payments upon the completion of employment. 90% of employees have signed up to the program. While future use of the site is unclear, the future use of its existing desalinization facilities is "off the table for now".
